On January 29, 2004, along with the Federal Courts Committee of the San Antonio Bar Association, the Chapter co-sponsored a dinner hosted by United States District Judge Royal Furgeson which was held at the Club Giraud for approximately 30 visiting United States Circuit Court and United States District Court Judges from around the country who were attending a case-weighting conference in San Antonio. The dinner provided members the opportunity to interact with the visiting judges on an informal basis and visit about issues of national concern.

# Pizza Mentoring Event

The FBA Chapter continued its support of Texas Celebrate Freedom Week in Texas public schools as a part of the Texas State Bar's initiative to work with school age children to teach the law and the importance of being a law-abiding citizen. Chapter Board member and U.S. Magistrate Judge Pam Mathy and U.S. Magistrate Judge Nancy Nowak helped work with the bar associations and school to develop and sustain this program through which female high school students at Fox Tech High School, a law magnet school in downtown San Antonio, are brought to the Judicial Training Center and given an opportunity to visit and hear women who work in the legal field talk about their career. On December 2, 2003, more than 90 girls and 30 women in the legal profession attended a pizza luncheon and mentoring event for all 9th and 10th graders at Fox Tech High. The event provided a forum for informal discussion about career options in the legal field. Women from the U.S. Attorney's office, Office of the Federal Public Defender, U. S. Probation Office, U.S. District Clerk's Office, U.S. Marshal's Office, as well as women attorneys in private practice and para-professionals spoke about career options and the struggles that many of the women overcame to achieve their career goals. The program is geared to encourage the girls to stay in school and do what it takes to succeed in spite of pressure from peers. #### **Celebrate Freedom Week Books**

In addition, through the initiative of President Beth Smith, the Chapter mailed out copies of the State Bar of Texas law-related book for Celebrate Freedom Week to each of the 102 3rd grade classes in each of the 81 private schools in the San Antonio area.
