The FBA Chapter and the Bexar County Women's Bar Association are pleased to co-sponsor again this year a pizza luncheon and discussion time with the 10th and 11th grade Fox Tech High School girls enrolled in the "Law and Research" magnet program on Friday, February 4, 2005 from 11:00 a.m. to 1:00 p.m. in the Adrian Spears Judicial Training Center, located across the bricked patio from the front door to the John H. Wood Jr. United States Courthouse.

Through this program, developed with the support of U.S. Magistrate Judge Pam Mathy and U.S. Magistrate Judge Nancy Nowak, the FBA Chapter continues its support of the Texas State Bar's initiative to work with school age children to teach the law and the importance of being a law-abiding citizen. We are pleased to work on this important project collaboratively with the Bexar County Women's Bar Association!

The purpose of the program is to provide a forum for informal discussion about career options in the legal field with the goal for encouraging girls who may be at risk for dropping out of school to stay in school and aspire to a career in the legal field. Last year's pizza lunch was attended by more than 90 girls and 30 women in the legal field. Women from the U.S. Attorney's Office, Office of the Federal Public Defender, U. S. Probation Office, U.S. District Clerk's Office, U.S. Marshal's Office, as well as women attorneys in private practice and para-professionals spoke about career options and the struggles that many of the women overcame to achieve their career goals.

You will be seated at a table with the students who will ask you questions about why and how you decided to do what you are doing and will seek your advice on how to excel. Region X Moot Court Competition

Our Chapter co-sponsored the Region X Moot Court competition held on November 11 and November 12, 2005 in the John H. Wood Jr. United States Courthouse. More than 40 Chapter members, local attorneys, and judges generously served as volunteer judges to judge the highest ranking student team at participating law schools in Region X, to include teams from law schools in Texas and Oklahoma. The moot court problem this year featured cutting-edge issues in federal criminal law and procedure. The final round competition was judged by United States District Judge Xavier Rodriguez, Texas Supreme Court Justice Paul Green, United States Magistrate Judge Pam Mathy, Richard Durbin (Criminal Chief at the United States Attorney's Office) and Donna Coltharp (Appellate Attorney at the Federal Public Defender's Office). The team from South Texas School of Law was selected as the winning team, with the team from St. Mary's School of Law selected as the runner-up. Both teams will advance to the National Moot Court championship rounds to be held in New York City. During the competition, the school affiliations of the competing student teams was not disclosed to the judges.
