San Antonio Chapter of the FBA's 2009 Lucien Campbell Award

For decades, the San Antonio Chapter has sponsored a federal civil procedure award at St. Mary's University School of Law to recognize scholastic achievement and excellence in civil procedural law through a cash award. The civil award program has evolved through the years into its current form in which the students who scores highest in each of the sections of federal civil procedure at St. Mary's receives a cash award. The Chapter long has aspired to expanding its scholarship program to include academic excellence in criminal law. We are gratified that we have been able to see this goal realized through the establishment of the Chapter's Campbell Award which – in recognition of the superlative service of a practicing lawyer in our bar – recognizes excellence in criminal law by acknowledging the students who scored the highest in each of the sections of criminal law at St. Mary's with cash awards.

Lucien Campbell, served 32 years as the Federal Public Defender for the Western District of Texas. He founded the Defender's Office in San Antonio in 1975, initially with just four other lawyers, two others in San Antonio and two in El Paso. Over three decades, Lucien managed the office ably through years of growth and tremendous changes in the federal system.

In the last ten years of his service, the Western District of Texas, as it does today, consistently ranks within the top three districts in the country in numbers of criminal cases filed, usually ranking first. Most of the individuals charged are represented by the lawyers of the Defender's Office at the trial level and on appeal. Lucien' service extended beyond the important work of the District to include service on national rule-making and policy-making committees which helped to earn him a well-deserved national reputation. On the occasion of his retirement, the prominent San Antonio criminal defense lawyer Gerald Goldstein said: "Lucien may be the single most important individual in establishing the federal defender system in our country." The Chapter is pleased to recognize the outstanding service of Lucien Campbell in connection with its support of St. Mary's University School of Law and the future lawyers of this District – and the San Antonio Chapter!

St. Mary's Lone Star Classic Call for Judges

The 2009 Lone Star Classic will be held on October 15-17 here in San Antonio. Sixteen law schools will be represented. The problem will be a criminal case, which will take place in the hypothetical state of Lone Star and will utilize the Federal Rules of Evidence.

The school is looking for 90 judges! The preliminary rounds will take place at the Bexar County Courthouse on Thursday, October 15 and Friday, October 16. The teams will break to semi-final rounds on Saturday morning, October 17, with the final round on the afternoon of the 17th, at the law school. Each round will take about two and one-half to three hours. The various winners of the preliminary rounds will be announced at a dinner buffet and reception on Friday evening; the judges are cordially invited to attend that event.
