For instance, three times per year the Chapter sponsors the Federal Court Practice Seminar which provides local practitioners with 5 hours of CLE (including 1 hour of ethics) training on federal practice and satisfies one of the requirements for admission to practice before the Western District of Texas. Every year the Chapter also sponsors advocacy competitions and scholarship programs at St. Mary's School of Law, rewarding top advocacy teams and high achieving students in federal civil procedure and criminal law with cash awards. The Chapter also conducts a mentorship program that matches Chapter members with law students interested in learning more from federal practitioners. Each year our Community Outreach Committee sponsors several outreach activities geared towards educating middle school and high school students about the federal courts and federal legal professionals, including, for instance, a lunch for young women enrolled in the Law Magnet Program at Fox Tech High School where women legal professionals have the opportunity to mentor the young women and share advice for pursuing careers in the legal profession.

2009 PARALEGAL OF THE YEAR

The Paralegal of the Year program has been adopted to honor an outstanding paralegal from San Antonio. This is not a popularity contest, but rather an award to a paralegal based on fair and impartial judging by a three person panel.

Below are the requirements for nomination and a nomination ballot. Each nominee's employer will be notified and will be asked to prepare a letter of recommendation reflecting his/her qualifications, experience, professionalism and the importance of his/her position in the firm.

The winner will be announced at the Paralegal Day luncheon on October 23, 2009. Please give serious consideration to those paralegals who have served well and worked hard this past year.

PARALEGAL OF THE YEAR PROCEDURE

Requirements for nominations:

- 1. Paralegal must be a voting member of either AAPA, STOP or PD.
- 2. Paralegal must have at least five (5) years of legal experience.

Notification process:

Each nominee will be notified upon receipt of ballot. Each person is then required to furnish the contact person the name of his/her supervising attorney who will be contacted to provide a letter of recommendation.
