The Younger Lawyers Division of the Federal Bar Association has invited our members to participate as a judge in the Thirteenth Annual Thurgood Marshall Moot Court Competition, which will be held on March 25 and 26, 2010, in Washington D.C. Each spring, law schools from around the country send teams to compete. As in the past, this year's topic will focus on emerging issues in federal law. Persons who would like to judge need not have prior moot court experience. An information packet, including a "bench memo" that explains the legal issues in detail, will be provided to each judge.
