

Zurek provided practical advice on how to decide on panel topics and how to approach potential speakers. and coordinated with the law student representative for the 5th circuit of the National FBA, Janell Thompson.

He grew up in Denton, Texas and went on to study digital journalism at the University of North Texas and write on local politics. After finishing his undergraduate degree, Samuel became a middle school history teacher, teaching Texas History and World Geography. He decided to go to law school to pursue a career as a litigator.

Samuel finished his first year of law school with an impressive list of accomplishments. After completing his first semester, Samuel made the Dean's List and was ranked 12th out of 302 first-year students. He competed in the Dave and Linda Schlueter 1L Moot Court Competition and the Jimi Derrick Moot Court Competition where he advanced to the semifinals in both events. He also has the honor of working as a research assistant for Professor Chenglin Liu and Dean Ramona Lampley. In the Fall Samuel will also be both a staff writer on the St. Mary's Law Journal and an advocate on the St. Mary's National Trial Team.

This summer, Samuel is interning at the Bexar County District Attorney's office in the Family Violence division. He is hoping to gain trial experience from observing court proceedings and aiding his advising attorneys in the gathering of evidence. Samuel is dedicated to becoming a career litigator who is most at home in the courtroom. He also cares deeply about financial and environmental justice and is considering either a career as a white collar prosecutor or a civil consumer protection attorney.

Regarding his future career goals, Samuel had this to say: "A lot of folks who don't have the resources to help themselves have been cheated by people with a lot of power in our society. There are powerful people who think they are above the law. I want to make it my mission to prove them wrong."

This year the San Antonio Federal Bar Association joined in sponsoring the 2023 Jimi Derrick Memorial Moot Court the Federal Competition at new Courthouse. As a demonstration of SAFBA's commitment to encouraging student advocacy the association donated \$5,000 to the competition and Many of the competition judges were executive members of the association

Student competitors were given the moot court problem only a few days before the competition and had to engage in simulated Appellate advocacy before volunteer judges.





The competition started with 12 competitors before it was narrowed down to the final four. 1L students Emily Garcia and Samuel Tunnell finished as semi-finalists and 2L Caitlin Sullivan finished as a finalist

1L student Daniel Ramirez took home the championship trophy along with the award for best rookie advocate. Daniel argued in the final round before U.S. Bankruptcy Judge Craig Gargotta and Fourth Court of Appeals Justices Beth Watkins and Lori Valenzuela. With the plan to continue honing his appelate advocacy skills further, Daniel will continue competing next year as as a new member on the St. Mary's National Moot Court Team.

The building, with its towering glass exterior, allows for large amounts of natural light. Details such as the visually striking backdrop of the central atrium stage will surely leave a colorful impression in the minds of all the court's visitors. The new courthouse also features many improvements to security such as restricted corridors, remedying the old courthouse's issue of jurors moving through the same spaces as detainees.

And while no guarantees can be made that the new technology will always run smoothly, having access to up-to-date tools is sure to make federal advocacy in San Antonio a more modern experience




THE NATIONAL CONFERENCE
